## APPLICATION FEE R 300-00 (SA Residents) / R 600.00 (Non Residents)

This is payable on submission of an application form for a place in the school. It is non-refundable and covers the cost of administration and assessment.

## REGISTRATION AND PLACEMENT FEE R 5 500-00 (Pre-rec to GR12) / R 1,000.00 (Nursery)

This is payable on acceptance of a place in the school. It is non-refundable and is applicable to children enrolling in Nursery through to High School prior to commencing at the school.

## DEPOSIT R 15 000-00

The deposit is refundable\*, provided **one full term's notice** has been given in to the school in writing. The deposit becomes payable within ninety (90) days of acceptance, or before the first day of school, whichever is the earliest. The deposit to the IES International Blouberg School (PTY) Limited shall be unsecured, interest free. The balance shall be repaid to you upon completion of your child's stay at IES International Blouberg School (PTY) Limited. It is applicable to children enrolling in Nursery through to High School.

A R15,000.00 deposit for Nursery will be payable in 3 instalments of R5,000.00 over 3 years.

\*R 1 000-00 development levy is deducted per annum from the Deposit held by the school

### TUITION FEES

Tuition fees are payable in advance before the beginning of the term. Delay in payment will incur interest charges (2% per month) and may result in the suspension of the student.

Extracurricular activities, uniforms, workbooks and stationery requirements are available for purchase via our online suppliers. (Quicket, Office Box, Waltons, Caxtons and Hatrick)

### SIBLING DISCOUNTS AND ANNUAL PAYMENTS

A reduction of 5% of the relevant fee is made for a second child in the School, 10% for a third child and 30% for a fourth child.

All fees paid annually in advance, before the end of the first school day of the new school year, will receive a 4.5% fee reduction.

### ADDITIONAL COSTS AND LEVIES

IGCSE exams for Year 10 are charged at £75 per subject invoiced in September 2020.

AS level exams are charged at £80 per subject invoiced in September 2020.

A level exams are charged at £80 per subject invoiced in September 2020.

A level non-refundable placement fee of R4 500 will be payable by 1 January 2020.

These costs cover Cambridge fees, invigilation, postage and courier services. Parents will be billed as per rate on the day of foreign exchange. Fees are payable in March and September 2020.

### NOTICE

One full term's notice in writing must be given to the Head of School no later than the first day of the last term that the student will be at the school. Failure to do so will result in the following term's fees becoming due and payable.
